At 9:09 a.m. the meeting of the Maryland Transportation Authority (MDTA) Capital Committee was called to order by Acting Chairman Gaines.

APPROVAL - OPEN SESSION MINUTES OF APRIL 6, 2017

Upon motion by Member Ensor and seconded by Member Cox, the Open Session meeting minutes of the Capital Committee's Meeting held on April 6, 2017 were unanimously approved.

At 9:10 a.m. upon motion by Member Cox and seconded by Member Ensor, the Members unanimously voted to move into Closed Session pursuant to Section §3-305(b)(8) of the General Provisions Article of the Annotated Code of Maryland to discuss pending litigation regarding SHA Contract No. AT3765D60 – MD 200, Intercounty Connector Contract D/E Modified Design Build project.

RATIFICATION OF ACTIONS TAKEN DURING CLOSED SESSION

Upon motion by Member Ensor and seconded by Member Cox, the Members ratified their actions taken in closed session to unanimously recommend approval of the negotiated settlement amount of \$6.8 Million for SHA Contract No. AT3765D60 – MD 200, Intercounty Connector Contract D/E Modified Design Build project resolving all outstanding contractual issues and delegating signature authority to the Executive Director to execute all necessary documents to finalize the settlement to the MDTA Board at its next regularly scheduled meeting.
